Constitution of India.

No. GH/SH/37/GCO/152008/3397/KH:— In Exercise of the powers conferred by the proviso to article 309 of the Constitution of India, and in supersession of all the rules made in this behalf, the Governor of Gujarat here by makes the following rules to provide for regulating recruitment, to the post of the **Librarian Class III**, in the Government Colleges in the subordinate service of the Commissionerate of Higher Education namely:-

1. These rules may be called the Librarian Class III. in the Government Colleges Recruitment Rules, 2010.
2. Appointment to the post of Librarian Class III, in the Government Colleges shall be made by direct selection.
3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall:
 - (a) not be more than 30 years of age.
 - (b) possess Master's Degree in Library Science or Information Science or Documentation Science or an equivalent professional degree with at least 55% of marks or its equivalent grade of 55% marks where grading system is practiced.
 - (c) be qualified in the National Eligibility Test (NET) or other accredited test like State Level Eligibility/lest State Eligibility Test in the Library Science conducted for the purpose by the University Grants Commission or any other agency approved by the University Grants Commission:

Provided that candidates who are or have been awarded Ph.D degree in Library Science or Information Science or Documentation Science in accordance with provision of the University Grants Commission (Minimum Standards and Procedure for award of Ph.D Degree), Regulations, 2010 shall be exempted from the requirement of minimum eligibility condition of National Eligibility Test or State Level Eligibility Test or State Eligibility Test for recruitment and appointment of the Librarian.

- (d) possess the adequate knowledge on computerization of Library.
- (e) possess consistently good academic record.
- (f) possess adequate knowledge of Gujarati and/or Hindi :

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Civil Service Classification and Recruitment (General) Rules, 1967.

4. The selected candidate shall be on probation for a period of one year.
5. The selected candidate shall, during his probation period,, be required to pass qualifying examination for computer knowledge in accordance with provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
6. The selected candidate shall be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
7. The selected candidate shall have to undergo such training and to pass such examination as may be prescribed by the government.
8. The selected candidate shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government in this behalf.
